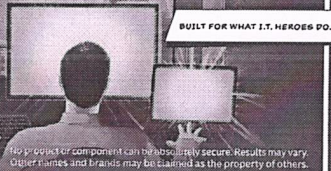

India to allow tourists on charter flights soon

Mumbai, 20 September

Vaccinated foreign tourists would be allowed to visit India on charter flights as the government plans to relax restrictions to enter the country. An announcement regarding the modalities and the date from which leisure travel can resume is expected by the end of this month.

Last March, the government clamped down on overseas air travel to curb the spread of Covid-19. While businesspersons, healthcare professionals, technical specialists and overseas citizens of India have been allowed since last year, leisure travellers are still denied entry.

Now, the government plans to open the doors to foreign tourists in a phased manner given the decline in Covid-19 cases and widespread vaccination. An official in the know of the developments said inter-ministerial discussions are going on and to begin with, vaccinated tourists would be permitted to come to India on charter flights.

NON-STOP FLIGHTS TO CANADA RESUME

Air India and Air Canada are resuming their flights from Delhi to Toronto and Vancouver with easing of entry restrictions by the North American country. While Air Canada's first departure from Delhi will be on Wednesday, Air India is yet to announce its schedule but has informed Delhi airport about its plan to start flights from Sunday. Canada earlier required travellers from India to do a RT-PCR in a third nation before giving them access.

Air Canada will only accept RT-PCR or a rapid PCR test taken no more than 18 hours before departure from a testing centre at Delhi airport.

RAMESH, THAROOR SLAM UK TRAVEL RULES

Former Union ministers Jai Ram Ramesh and Shashi Tharoor on Monday slammed the UK's Covid-19-related travel rules under which Indians vaccinated with Covishield would still be treated as unvaccinated.

Ramesh said the rules smacked of racism, while Tharoor said that because of the restrictions he had even pulled out of a debate at The Cambridge Union debating society and from the launch events for the UK edition of his book, *The Battle of Belonging*. Passengers, who aren't recognised as being fully vaccinated with authorised vaccines under England's international travel rules, including Indians, will have to take a pre-departure test, PCR tests on days 2 and 8 of arrival, and self-isolate for 10 days upon entry.

RECOVERY TRACKER Power generation and freight data show slower growth

Bus, train and other transit visits rise to 99.1% of pre-pandemic levels

Power generation and goods that the Indian Railways carried have dropped from the higher growth numbers seen in earlier weeks.

The average amount of electricity generated in the country was lower than in the previous week. Power generation is now down about 15 percent over the recent high of around 4,500 million units per day on average in the middle of August this year. Over 3,800 million units of electricity were generated per day on average during the week ending September 19. This is marginally higher than the average in 2019 but lower than the corresponding week in 2020. At its peak, power generation was 26.6 percent higher in August than was seen during the same period in 2019 (see chart 1).

The Indian Railways showed a slower growth in goods carried than before. The quantity of goods carried for the latest week was up 0.3 percent compared to the same period last year. It was 5.8 percent in the previous week. Similarly, the growth in the amount of money that the Indian Railways made from carrying goods dropped from 1.2 percent to eight per cent (see chart 2).

At 99.1 per cent of what was seen before the pandemic, visits had been trending up. They touched their high during the Ganapati festival that lasted a number of days in Maharashtra. Important festival days included Ganesh Chaturthi, which was on September 10, and Ganant Chaturthi on September 19. Search engine Google says an unmythical location data to track how people are moving during the pandemic. The data is released with a lag. The latest is as of September 14 (see chart 3).

Business Standard also tracks emissions of nitrogen dioxide. It comes from vehicles and industrial activity. Delhi's emissions were 25 per cent below normal as in 2019. This was marginally better than the 26.6 percent below the 2019 figure seen in the previous week. Mumbai's emission gap over 2019 widened to 47.7 per cent (see chart 4).

Traffic showed a mixed picture. New Delhi traffic had come back to 90 percent of normal in the latest week, shows data from global location technology firm TomTom International. It was 88 per cent in the previous week. Mumbai traffic was down amid the Ganesh festival (see chart 5). The total number of vehicles registered for the week ending Sunday, September 19, was 290,516. This was six per cent lower than

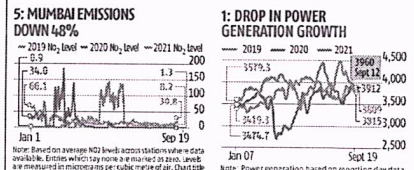
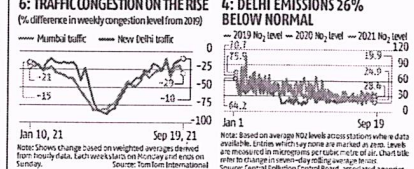
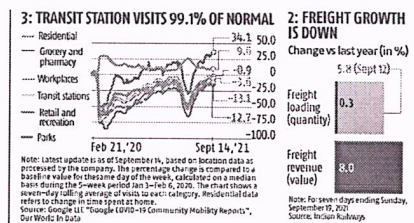


Figure of 310,725 seen for the same period in 2020. It is down 20 per cent from 2019's figure of 362,184. Business Standard tracks these indicators on a weekly basis to get a current sense of the country's economic health. Official macroeconomic data is often released with a lag. Analysts globally have been using similar indicators to track how economies are doing as different countries went into lockdown to control the Covid-19 pandemic. Google data is released with a lag. The latest is as of September 14. All other data is as of Sunday, September 19.
