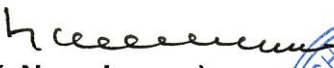

- The Company operates mainly in one segment i.e., Manufacturing and Marketing of Pesticide Formulations.
- The Company has decided to exercise the option permitted U/s 115BAA of the Income Tax Act 1961 and Current Tax is worked out accordingly.
- The figures of the last quarter of F.Y.2023-24 are the balancing figures between audited figures in respect of the full financial year upto March 31, 2024 and the unaudited published year-to-date figures upto December 31, 2023, being the date of the end of the third quarter of the financial year which were subjected to limited review.
- Previous period figures have been reclassified/ regrouped, wherever necessary to make them comarable .
